To Race as 3-Year-Old OS Filly Pacers and OS Filly Trotters:

Declarations must be made by Tuesday, May 15, 2012 at 10:30 am.

Finals – Friday, May 25, 2012 (\$160,000 E each gait)

Woodbine Entertainment Group will add \$100,000 to the stake. \$50,000 to the filly pace and \$50,000 to the filly trot.

1. Eligible: Ontario-sired filly pacing and trotting yearlings, who were foaled in 2009 and were sired by a stallion that stood for the 2008 breeding season in the province of Ontario. Separate events for filly pacers and filly trotters.
2. If the May 15, 2010 yearling nomination fee is not paid, 2-year-olds can be nominated by paying a late nomination fee of \$1,000 on Feb. 15, 2011.
3. If more than 10 horses declare to start, the race will be contested in one or more eliminations.
If 10 horses or less declare to start, the race will be contested as a single dash.
4. If there are one or more eliminations, the final event will be limited to 10 horses.
5. If there are one or more eliminations, one "Also Eligible" will be drawn from the highest place starters that do not qualify for the final event. If there are ties, the "Also Eligible" will be drawn by lot.
6. All races at one mile.
7. All nominations, sustaining, and added monies will be divided equally between the trot and pace. Starting fees will be added to each separate gait to create a separate total purse for the trot and pace. Each elimination will race for a purse of \$25,000.
8. Woodbine Entertainment Group will not accept inadequacies of the postal system as an excuse for late payments. It is therefore suggested that payments be made by registered mail to ensure safe delivery
